

WEST MARKET COMMUNITY ASSOCIATION VEHICLE REGISTRATION FORM 2008-2009

(for use by all WM residents other than those in Madison Park)

Commencing March 1, 2008, any vehicle without a West Market parking sticker or hang tag that is parked for longer than 24 hours in a West Market Common Area space (a non-designated street-side parking space) may be towed. For the complete regulation, see <http://www.westmarket.net/docs/ParkingResolution.pdf>

One sticker will be issued for each eligible vehicle. Stickers must be permanently affixed to the inside upper corner on the passenger side of the front windshield (or prominently displayed in the case of motorcycles). Residents may obtain a hang tag in lieu of one sticker. Hang tags may only be used for vehicles of a resident or his/her guests, and must be hung from the front mirror or prominently placed on the front dash. Stickers/hang tags will be valid for two-year cycles.

To obtain stickers, residents must complete this form and file it with the On-Site Manager, *together with a copy of proof of current State registration (either a copy of the registration or insurance card) for each vehicle for which a sticker/hang tag is sought.* You may download this form from the web site and file preferably by e-mail WMvehicle@westmarket.net (scanning and attaching proof of registration) or by fax (703-435-8952), mail, or personal delivery to the On-Site Manager, Karen Fegani, at the Club House (1901 Logan Manor Drive). Proof of residence may be requested. Once you are registered, the appropriate number of stickers and/or a hang tag will be made available for you to pick up at the Club House or will be delivered to your unit.

If a vehicle is registered in the name of your employer or corporate entity, please check to confirm that such vehicle has been provided for your regular personal and/or business use.

Please check if you would like a hang tag in lieu of one sticker.
